#### Overview:

- Educate families and caregivers on implementing therapy strategies at home and in community settings to reinforce skill development.
- If therapy is school based, work closely with educators, paraprofessionals, and other team members to create an inclusive support system, ensuring therapy goals align with academic and social expectations.

- Maintain precise records of assessments, treatment plans, and progress notes in secure electronic health records (EHRs), in compliance with HIPAA.
- Ensure that therapy documentation meets all state and federal requirements for pediatric therapy, reporting progress to families and other involved professionals as needed.
- Prepare and submit reports required for insurance reimbursement, aligning with Georgia's state and federal billing guidelines, and participate in regular audits to maintain compliance.
